## NEW BUSINESS

The motion for all of the budgets passed.

A motion was made and seconded regarding our funds at the regional level. The motion reads as follows: To task the RSC to set aside \$2,000 per year to help struggling areas to make it to the RSC by having two paid rooms available, one for men and one for women; and to help with funds for gas not to exceed \$50 per area, per region. Intent: To help areas attend the RSC which in turn gets the necessary information to those groups in that area and helps carry the message. \*Note\*: This is separate from the regional motion (attached) that seeks to send world donations quarterly instead of annually.

6.4 Regional Budget

All funds over this prudent reserve and the amount evaluated and approved for the annual operating expenses will be forwarded to the WSC Treasurer annually in the month of January. The only exception to this 25% rule will be the expenses of the RD and AD to the WSC, which will be estimated and kept on hand four (4) months prior to WSC.

B. RCM's use the following formula to set the annual prudent reserve to be maintained (25% of the following approved annual budgets: RSC operating expenses and Subcommittee budgets). All funds over this prudent reserve and the amount evaluated and approved for the annual operating expenses will be forwarded to the WSC Treasurer quarterly in the month of the RSC meeting. The only exception to this 25% rule will be the expenses of the RD and the AD to the WSC, which will be estimated and kept on-hand four (4) months prior to the WSC.

INTENT: To better utilize the funds available to the RSC and the other service bodies and to eliminate the accumulation of excess funds at the Show Me Region Service Committee.
