I spoke with David B. last week and I agreed to go to RSC in July and sit in as RCM (if this service body approves.) David hasn't had a chance to sit in an RSC in an RCM Alt. capacity and would like to once just to get a feel for what goes on.

July's RSC will be hosted by OASC. I asked the Regional trusted servants what kind of function they would like to have and several suggested a Speaker Jam. Jackie C. has agreed to speak. The RD and the RDA have videos from WSC that they would like to share. So they would be the second speaker. Then there is a video of Jimmy K and some of the other old service junkies that we want to show. Oh I forgot to mention, July will be the Region's 25th anniversary. We will also do a raffle and 50/50. We will need raffle items for that. I will also need \$300 which the Region will reimburse.

In the past I have mentioned that the Region set up a Yahoo group for the RCM's to communicate in between RSC's. Thanks to this Yahoo Group, we can get updates in between RSCs. When the RD and The RDA went to the WSC they sent us daily updates. The motions for the Basic Text all passed. I won't have the break down of the votes until July. Also I have attached a Service IP for anyone interested to review. At the WSC, the RD's voted to have all service IP's sent back for a review process. I am not sure what this process is, but I do know we only have a short time to review the IP attached. I will find out more at the RSC. Also, Thanks to the Yahoo Group, there is some controversy going on between the Executive committee and the RCM's. At the April RSC the RCMs voted to lower the mileage reimbursement from .48 - .52 to .25 per mile. One of the Executive's that was not present is very upset about this decision and wants it to go back to .52 a mile which is what the IRS states for business travel. However the RSC is not a business, its volunteer work which falls under a different category and I think that the IRS says .19 a mile for reimbursement. The RD and The RDA were going to drive to the SZF in Tn. but since they can't have their .52 a mile they have decided to spend \$1200+ on plane tickets. I am sure this will be a very heated topic in Open Forum. I would like to know this service bodies thoughts on this, because I think .52 a mile is ridicules and that is just my opinion.

The next controversy pertains to WSR (Writing Steps in Recovery) The WSR Chair received a check for \$2000 to attend the WCS. When reading her report at the April RSC she said nothing about needing this money. However, the report she turned in for the minutes states that she planned to attend the WSC. Then in the treasures report there is a \$2000 reimbursement. This will be another heated topic in Open Forum.

The RSC has received one check for \$260 from the past Treasurer. At this time I do not know if the check cleared the bank.
